WHEN: August 18th thru the 20th.

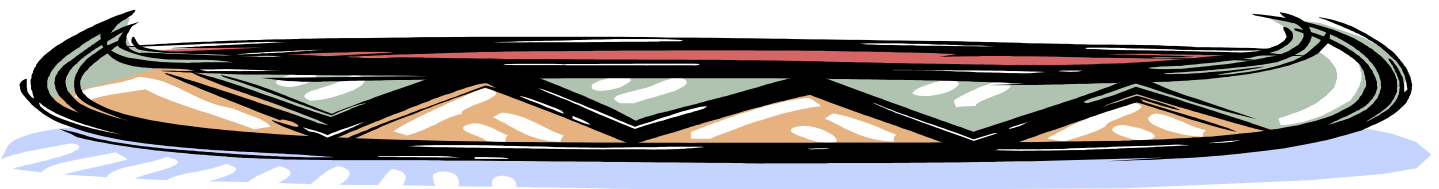
ACTIVITIES: Camping, Canoeing a Class 1 Section of the Yough River, Swimming, Fishing, Fellowship, and a lot Fun

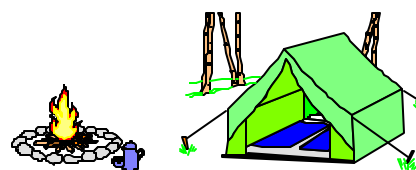

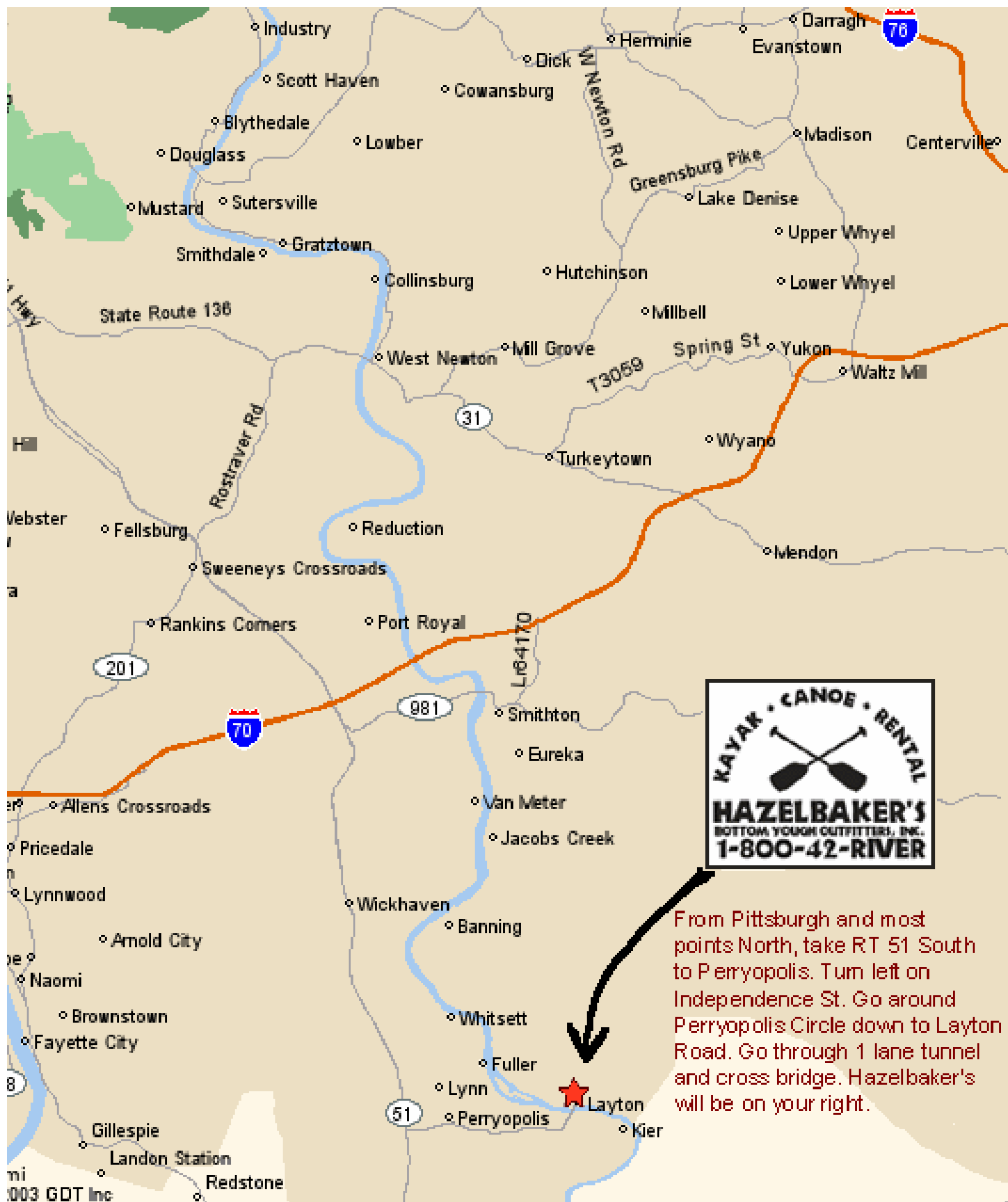
